### Keep the momentum going; elect a forward-thinking Board on June 28

 $\mathbf{I}$ t's been a good year for NNI, starting in June when our Member neighborhoods elected hard-working dedicated. board. First, we hired two key staff people to manage the organization. Our new Director of Operations, Christy Harris, wasted no time modernizing our business systems and office layout. Christy brought a welcome sense of order and professionalism to NNI. Jim Rice, our Executive Director, shored up essential funding from the City of Kansas City and the Local Initiatives Support Corporation (LISC), and nailed down our contract to manage the Chouteau Housing and Maintenance Program (CHAMP). Thanks to CHAMP, we will complete repairs to 240 homes by late summer.

Working with Councilperson Deb Hermann and the City's Department, Housing launched our first New and Rehab Housing program. We have completed two houses and two more are on the way. The Board also approved a partnership with Cohen-Esrey Development to convert the old Eastwood School into senior apartments. To tie it all together, we recently rolled out an exciting new program called NEIGHBORHOOD SOLUTIONS. It combines our neighborhood

organizing effort with our Neighborhood Information Center. Another strong staff addition, Riki Carter, manages this important program.

Yes, NNI has momentum. And, the best way to keep that positive momentum going is to elect a strong, forward-thinking Board of Directors at NNI's Annual Meeting on June 28. The NNI slate includes four current board members running for re-election, one person running for an open seat, and two recent board appointees who must be ratified by the Member neighborhoods.

I have served on the board for three years and as President since October 2003. I am running for my second term. If

# Bulky item collection clarified

There has been much confusion this year with regard to bulky item collection. Effective January 1, 2004, bulky item pickups are scheduled **every other** month and the date depends on which zone you are in.

Collections in Zones 3, 5, and 7 are in the odd months (January, March, May, July, September and November). Collections in Zones 6 and 8 are in even months (February, April, June, August, October and December).

To determine which zone you are in, you can either check the city's Environmental Management website (www.kcmo.org/environ.nsf/web/bulkynorth) or call 513-3490.

## Focus on FOCUS: Code enforcement a key part of FOCUS Center activities

**"Focus on FOCUS"** is a new column in the quarterly addition of Northland Neighborhoods. Code violations are a huge concern and this column will answer some of your questions.

Now that Spring is here, a couple of codes reminders.

Bulky item pick-up dates have changed. Citizens are asked to place bulky items out one day before their bulky item pick-up date. Bulky items are considered trash and a violation of Chapter 48 Nusiance Code. Citizens can call Environmental Management at 513-3490 to check the new bulky item pick-up dates.

Second, the city's cold weather policy expires May 1, 2004. The cold weather policy is done on a yearly basis. This applies to citizens who received notice and order letters dated between November 1, 2003 and April 1, 2004. Also, the cold weather policy is for painting and concrete violations only. If violations have not been corrected by May 1, 2004, and an extension is denied, a summons to court will be issued.

FOCUS Centers grew out of FOCUS Kansas City (Forging Our Comprehensive Urban Strategies). NNI is one of such centers in the city

Any weeds or noxious plants, which include grass and unattended growth over 10 inches high, are violations of Charter 48 Nuisance Code. The city requires citizens to keep their yards free from these violations. Citizens will be sent a warning letter explaining the violations and time to correct the violations. Failure to correct violations will result in a summons to court.

Finally, a brief look at the code enforcement process. First a complaint is turned into the city. A letter is sent to inform the occupant and/or the owner of the violation. The city gives a due process of time to correct the violation. A city inspector then will inspect the property in question, and determine if the violation has been corrected. If the violation is not corrected the city inspector will issue a summons to court. Reminder, the city inspector is required to continue to issue summons until all violations on the property have been corrected. Complaints against members of the Kansas City, Missouri Police Department can now be made at Northland Neighborhoods, Inc., 5312 NE Chouteau Trafficway.

The opening of this satellite office is a priority of the Office of Community Complaints (OCC), as well as the Board of Police Commissioners. Community members have more choices available to them on where to file complaints or to bring issues to the attention of OCC.

In addition to the NNI site, complaints can be submitted at the Office of Community Complaints, 635 Woodland Avenue - Suite 2102; MOVEUP, 3330 Troost, the Kansas City Missouri Police Department Headquarter; or any division station.

The Office of Community Complaints conducts investigations into allegations of misconduct against members of the Kansas City, Missouri Police Department.

When our neighbors, the Millers, light their Stars and Stripes in the front window, we know their daughter Taryn of the 139th Logistics Group, Air National Guard based in St. Joseph, has returned to Iraq. It is glowing now.

Surfacing from my WWII memories was that plaintive ballad, "Say a Prayer For The Boys Over There," leading me to wondering if Northlanders are praying for our troops in Iraq and Afghanistan. Wondering where are the yellow ribbons and who is conducting care package drives.

I discovered that, although we do not house a military base or a large reserve unit, Clay and Platte residents in many quiet ways are indeed remembering those troops now in harm's way.

Firefighter Robert Walker, a Marine reservist on duty in Iraq, has a new, much needed septic tank at his home on North Hardesty, thanks to fellow firemen and other volunteers. The widow of Silver Star hero Sgt. Donald Walters has the caring support of her church, Winnwood Baptist, and VFW Post 4050 in North Kansas City.

When Briarcliff Elementary School's 3rd grade teacher Jan Lamberth learned that American troops were requesting school supplies for Iraqi children, she organized a drive with kids collecting pencils, crayons, rulers and spiral notebooks, giving "their hearts and their enthusiasm" to the effort. In their box of over 2,700 items they tucked a disposable camera and a return address. (What better ambassadors of good will toward the Iraqi people could there possibly be?)

On the Antioch Library's bulletin board and on school walls are "Heroes Lists," displaying the names and photographs of Northlanders on active duty.

For months, ladies of the American Legion's Elmer Ellis Post 33 in Smithville have been knitting slipper socks for "Operation Toasty Toes." VFW Post 5606 in Kansas City North donates funds for phone cards and collects movie tapes, especially comedies and westerns. "You can't go wrong with a John Wayne movie," explained post Auxiliary treasurer Bertie Cooper.

As part of "Operation Support Our Troops," a 501(c)(3) non-profit organization, a devoted, homefront effort is ongoing in Platte City. It involves VFW Post 4055, Auxiliary member Edith Prost, the First Baptist Church of the town and the Prost basement. On the first Thursday of each month, volunteers gather to pack a wealth of donated items for shipment to the front.

Edith and her cohorts also sew "neck coolers," a scarf filled with crystals that, when wet, provides welcome relief from the desert heat. Using Edith's pattern, Northlander Marg Merchant and even my husband are making the coolers from camouflage-pattern fabric.

All of us can do more for our servicemen and women through our churches, schools, clubs and work places. One cannot mail things directly to "a soldier in Iraq." A contact person or unit is needed. In Platte City, for instance, Edith Prost's son, an Army chaplain in Iraq, is their contact.
