

### Persistence, hard work pay off as new playground emerges in Golden Oaks Park

**B**renda Ellis doesn't give up easily. Ellis, president of the Golden Oaks Neighborhood Association, has campaigned tirelessly for improvements to Golden Oaks Park for several

years. On Saturday, November 13, her efforts paid off as dozens of neighborhood volunteers, Parks and Recreation workers, and police officers came together to assemble the

massive, brightly colored components of a new playground.

The morning began with small pockets of volunteers pondering instruction booklets and wondering how the mind-bending piles of playground parts would ever come together. But, by day's end, an impressive new playground had taken shape and was ready for a whimsical trial run by the young and the young at heart.

The playground is phase one of several improvements yet to come, including a walking trail. The playground equipment was funded by \$35,000 in Kansas City's sales tax for public improvements program (PIAC). NNI worked with Ellis and Councilwoman Deb Hermann to secure the PIAC grant.

#### Connections Meeting:

#### **CHAMP Update:**

The Chouteau Housing and Maintenance Program (CHAMP) began in September 2003 and will conclude by January 2005. As of November, repairs averaging more than \$4,000 per home have been completed on 189 by their homes. Inspired CHAMP neighbors, other homeowners in Chaumiere and Winnwood-Sunnybrook neighborhoods have invested nearly \$400,000 of their own funds to make additional repairs. The new roofs, siding, windows and driveways have created curb appeal and energy efficiency in the two targeted neighborhoods.

#### SBC grant:

Southwesten Bell has notified NNI that it will receive an \$8,000 Excelerator Grant for technology training. The grant is a follow-up to last year's \$20,000 award to develop NNI's Neighborhood Information Center. The new grant will provide computer training to staff, volunteers and neighborhood leaders.

### Fall 2004 leaves and brush recycling program outlined

Leaves and brush must be placed on the curb by 7 am. The schedule for curbside leaf and brush pick-up is as follows:

#### If your trash day is:

Wednesday - pick up is Dec. 6 Thursday - pick up is Dec. 6 Friday - pick up is Dec. 13

The requirements are: use only paper lawn debris bags sealed only with masking tape. Do not seal with any plastic or duct tape. Do not include trash or grass clippings. Maximum weight is 40 pounds.

Bundle your brush with string only in lengths less than or equal to 4 feet, 2 feet in diameter, and 40 pounds or less. Exclude brush that is greater than 3 inches in diameter. Do not use wire or plastic tape to tie brush in bundles. Use twine or jute rope only. Place no more than 15 bags and/or bundles per household at the curb. Place bundles and

paper leaf bags at the curb by 7am on Monday of your scheduled week.

Weather permitting, leaves and brush will be picked up from the curbside within six days of the date noted. Cover bags and bundles with clear tarps to protect items from the weather. Dry bags are less likely to tear and leave yard waste behind.

The City processes the material collected in the Leaves and Brush Recycling Program into mulch and compost to be used by the City and its residents.

Free mulch and compost are available at the leaves and brush drop-off sites.
