



CD2000 goes south (of the river); NNI gearing up to fill \$144,000 funding gap

n April 2006, Northland Neighborhood's budget will drop by \$144,000 because funds are being shifted from an important city-wide community development program called CD2000 to a new program,

Under CD2000, community development corporations prepared annual strategic plans, reported progress each quarter, and received a grade card based on their performance in reaching strategic objectives. If grades went up, so did financial support from CD2000.


NNI managed to improve its grade three years in a row. Jim Rice, NNI executive director, feels the demise of CD2000 is more than a financial loss. "The strategic planning and the rigorous discipline of the reporting process were central to NNI's progress over the past three years," Rice says. "We all knew the program

would not last forever, but I think it needed a few more years to achieve what it set out to do."

Despite the challenge presented by the fading of CD2000, Rice and his Board leadership are optimistic about NNI's future. "We will aggressively seek additional foundation and corporate support," says NNI Board President Mike Lewis. "Northland businesses and institutions have a real stake in the health of our neighborhoods. This will be their opportunity to stand up and be counted."
