ENCORE HOME REPAIR PROGRAM UNDERWAY

Targeted home repair returns to North Oak corridor neighborhoods this month, thanks to the North Oak TIF plan. The program ultimately will be financed by the sale of \$1 million in TIF bonds, but the economic recession temporarily ruled out a bond sale. However, the developers of North Oak Village at Vivion and North Oak advanced \$200,000 to jump start the home repair program. So, the first phase of home repairs will get underway now.

Homeowners in the North Oak Benefit District who meet income guidelines may be eligible for a home repair grant of up to \$4,500 for improvements such as roofs, windows, siding, heating and air conditioning, driveways and other non-cosmetic repairs. Homeowners above income limits can also obtain a grant, but must match it dollar for dollar. Boundaries of the benefit district are 47th Street/I-29 on the north, 32nd Street on the south, I-29/I-35/Woodland on the east, and North Main on the west. The program is called ENCORE (Enhancing Neighborhoods by Concentrating Organization, Resources & Energy). With ENCORE, NNI hopes to build on the past success of the CHAMP and SMART targeted home repair programs. Homeowners in the targeted area may pick up an application at the NNI office, 3015 NE Vivion Road.

native of St. Joseph, Missouri, Trish Martin is one of the Northland's star volunteers.

Trish graduated from Platt College in 1983 with an Associate degree in electric drafting. She earned a second associate degree from DeVry Institute in 1988. Her career history includes positions with Mobay Chemical, HNTB, Black and Veatch. She retired in 2008 from URS Corp.

After living in Grandview, Belton, mid-town and Raytown, Trish chose the Northland for her first home purchase in 1993. She shares the home in the Shoal Brook II neighborhood with daughter Tia and grandson John. Having learned the neighborhood once had a homeowners association, she sent a letter to all neighbors asking if they had an interest in resurrecting the HOA. The response was unanimously negative and Trish tabled the effort for another day. A couple of years later she read an article in the paper about NNI and started attending meetings there. Her volunteer efforts grew out of the association with NNI where she has helped with mailing lists, Night Out against Crime Kick-Off, Safe Trick or Treat, answering phones, and updating databases. She played a pivotal role in developing NNI's recent HOA Workshop and training manual.

With NNI's support, the neighborhood association of Shoal Brook II was formed in 2008 and Trish, as the instigator, was elected president. She graduated from NNI's 2009 EXCEL Neighborhood Leadership program and the Community Leadership Program sponsored by the Kansas City Neighborhood and Community Services Department. She learned about the Kansas City Neighborhood



Advisory Council and was elected to this organization in 2008. She was later appointed to the Regulated Industries Alcoholic Beverage Advisory Group.

"I enjoy the rewards I receive for my efforts to help others," Trish says. "I learn so much in the process that I wind up getting back much more than I give. It's really the volunteers that are the engine of Kansas City, my adopted home, and I'm so pleased to be a small part of that driving force."

KCMO TO CONDUCT PET LICENSING

PET LICENSING IS A SERVICE OFFERED AT NNI'S OFFICE, CALL 454–2000 FOR MORE INFORMATION.

The City of Kansas City Animal Health and Public Safety Division will conduct weekly pet licensing enforcement throughout the City from May 5, 2010 through September 1, 2010. This initiative is part of an effort to educate residents on animal health and safety, while improving neighborhood livability.

During the enforcement period, officers will inspect targeted areas for compliance. Citations may be issued to pet owners without a current pet license. City ordinances require residents to license dogs, cats and ferrets. Failure to comply will result in a citation being issued and a minimum \$75 fine. The license fee for a pet is \$10 for a spayed or neutered animal and \$33 for an animal that has not been altered.

Licensing a pet and keeping the license on the pet's collar helps ensure the pet's owner is notified should the pet be impounded by the Animal Health and Public Safety Division. Residents of the City are provided three methods for licensing a pet:

- Visit Halfway Home Pet Adoptions (the City's animal shelter), at 4400 Raytown Road
- Contact a veterinarian
- Visit Pet Data online by visiting www.petdata. com/cs/kcm/

When licensing a pet, the owner must provide a copy of the pet's current rabies vaccination certificate and proof of the pet's sterilization (if applicable). To obtain vaccination, contact a local vet or low-cost clinic such as Spay and Neuter Kansas City at 816-353-0940, or Halfway Home Pet Adoptions at 816-921-0201. For more information about pet license enforcement or animal health and public safety, contact Patrick Egberuare, manager of the Animal Health and Public Safety Division of the Neighborhood and Community Services Department, 816-513-9009.

NNI seeks qualified low-income home repair contractors

At its May 17 meeting, the Northland Neighborhoods Board of Directors endorsed the June 8 Special Election for a 1/4 cent sales tax for public safety improvements in Gladstone. If approved, the sales tax would fund additional law enforcement officers for patrol, criminal investigations, and neighborhood policing, as well as replace the outdated emergency radio communications system.

PERSPECTIVES Putting the Northland spirit to work on Lorie's House by Jim Rice

Construction is underway on Lorie's House, a new universal design home at 4413 N. Kensington in the Winnwood-Sunnybrook neighborhood. Universal design means that the house is designed and constructed to be accessible throughout the stages of a homeowner's life. It includes features such as extra-wide doors, cabinets and light switches at wheelchair height, walk-in showers, grab bars in bathrooms, and wheelchair-accessible walkways and entrances.

The new homeowner will be Lorie Perdieu, a local advocate for the disabled who has herself been disabled since birth. Though confined to a wheelchair, Lorie is able (with occasional assistance with daily living activities) to live by herself, drive a specially equipped van, and earn a modest income. Despite the many obstacles she has faced since infancy, Lorie has become an articulate and tireless worker for the disabled. Lorie's House is an opportunity to recognize Lorie and let the world know how productive and independent disabled persons can be...with a little help.

The project is a collaboration of Northland Neighborhoods, Inc. (NNI), the Christian Carpenters, and the Fuller Center for Housing. The Fuller Centers, growing out of the Habitat for Humanity experience, is a nationwide organization. The Kansas City Fuller Center is among the first in the region. Financing is supported by a \$60,000 HUD grant to NNI, cash and in-kind contributions from the Christian Carpenters, and contributions from the community. Lorie will also contribute through a mortgage that she can manage on her small income. Following a May 5 article in the Neighborhoods section of the Kansas City Star, the Northland spirit started to percolate, with ordinary—really quite extraordinary—residents sending along checks to help get Lorie's House finished. We need to keep this grassroots momentum going and we can do so only with your help. The basic, no frills house will cost approximately \$96,000. We'd like to do some modest landscaping and perhaps provide some new furnishings and appliances to make Lorie's first homeownership experience truly special.
