The Litter Index is an opportunity for Kansas City residents to view their community through new lenses as they help Bridging the Gap show the impact litter has on Kansas City. Following a group training, volunteers work in car-based teams using neighborhood maps to observe the level of litter in a neighborhood. The volunteer teams give each area a score based on the amount of litter present. These scores are used to produce an annual report of litter trends. On Saturday, March 19, the 11th Annual Litter Index will happen in the Northland beginning with breakfast and training at 10 a.m. and concluding by 2 p.m. Meet at Northland Neighborhoods, Inc., 3015 NE Vivion Road.
