Sears stalls Antioch legal roadblock delays demolition

Kansas City Business Journal reports that Sears filed a restraining order

The July 29 issue of the Kansas City Business Journal reports that Sears has filed a restraining order halting the planned start of demolition on Antioch Mall. "News of Sears' action, filed June 27, came just weeks

after Antioch Redevelopment Partners learned that it had won Missouri brownfield tax credits, which would help defray the cost of demolition," the Business Journal stated. Jim Rice, NNI's Senior Associate for Planning and Development, stated in

the article that he was "elated by one piece of news and then taken down by the other piece of news. They're (Sears) hurting the neighborhood. By holding this up, they're just allowing the cancer to metastasize. And it is. You can see it day by day."

NNI to launch Home repair blitz

Two recent grants will allow NNI to establish a long-needed home repair revolving fund that will expedite contractor payments and KCMO reimbursement for NNI's home repair expenses. NNI CEO Deb Hermann has set new production goals that will mean more opportunities for eligible homeowners to get needed repairs. To be eligible, you must be a homeowner residing in Kansas City, Missouri and household income must be below 80% of median income. (For example, a family of 2 with a total household income of \$46,300

qualifies.) Kinds of repair include heating and cooling repair and replacement, siding, windows, electrical, flatwork (concrete), flooring repair, plumbing, exterior painting, bathroom repairs, barrier removal, handicap accessibility or any other type of repair or replacement service that is not considered essentially cosmetic. NNI will also look for opportunities to make energy-efficient repairs that can lower household utility bills.

Be a good neighbor; check for code violations

At your own house

NNI is borrowing a program used by the Gracemor-Randolph Community Council to nip code violations in the bud. The form below (now available at NNI) can be used to inspect your own property. The form is simple and non-technical, but it can help you identify real or potential problems. This simple self-inspection can help maintain your property value and spruce up the neighborhood at the same time. Checking “NO” may mean that you are in violation of a Kansas City ordinance. Violations can result in expensive inspection fees and fines of up to \$1,000. This is not a complete list of possible ordinance violations. If you have questions about specific ordinances, call 3-1-1 or (816) 513-9010.

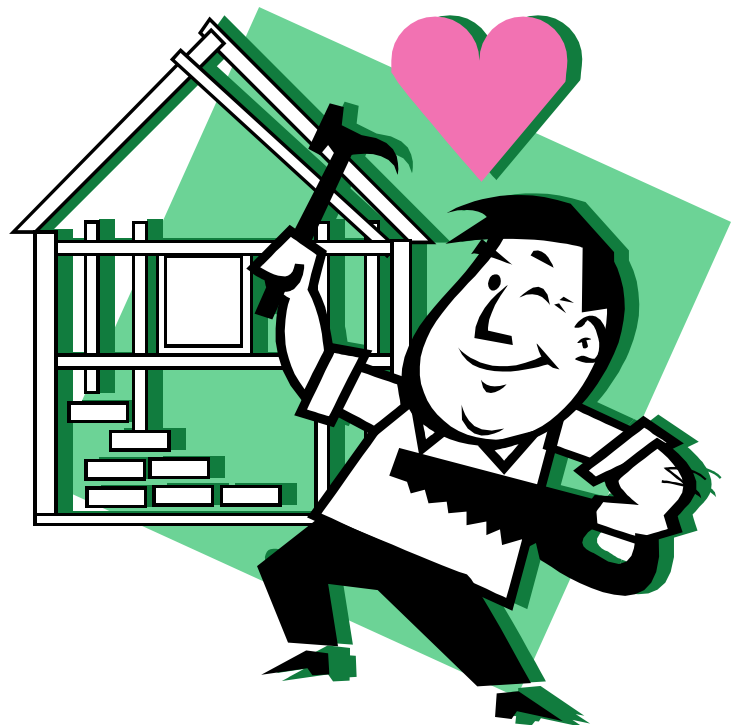
Get fired up about safety at August senior workshop
