MODOT PROJECT UPDATES

MoDot has closed the 169 HWY ramp to I-29 to perform bridge repairs. The closure will last through May 22nd.

This will be a 24/7 closure. All work is weather dependent. Drivers should allow ample time to detour via Route 9 to I-635 or I-29.

KCPD TO ENFORCE SUMMER CURFEW

The City of Kansas City has, for many years, had a juvenile curfew effecting youth under the age of 18. The curfew was enacted for the safety of our children and our neighborhoods.

It is unlawful for any person under the age of 18 to loiter, wander, stroll or play in or upon public places. Places are defined as public streets, alleys, parks, playgrounds, vacant lots, alleys, structures, buildings, places of amusement and eating places.

This curfew applies to all unsupervised youth be-

tween the hours of 11:00 PM and 6:00 AM the following day on a Sunday through Thursday or between the hours of 12:00 midnight and 6:00 AM Friday and Saturday.

It is the parent or guardian's responsibility to make sure children are abiding by the curfew. Upon conviction of a violation, parents or guardians shall be subject to a fine not to exceed \$500 and costs.

Police are authorized to detain persons under the age of 18 until they can be released to a parent or legal guardian. The Kan-

sas City Police will be conducting curfew sweeps in the weeks and months ahead.

Northland Neighborhoods will hosting a meeting with police to discuss their enforcement of the curfew and answer questions.

Mark your calendars for Monday, May 23rd, 7 PM. The meeting location is 4420 NE Chouteau Trwy.

Families are encouraged to attend the meeting.

NEIGHBORHOOD PROGRAMS ACCEPTING APPLICATIONS

The City of Kansas City Department of Neighborhoods and Housing Services has opened up its application window for three home improvement programs. The application period will be May 1st & end September 30., 2016.

The three programs are Paint Program, City Home Repair Program and Targeted Minor Home Repair program. Each program has qualifying criteria.

The Paint Program provides free paint and supplies, the City Home Re-

pair assists home-owners who cannot afford to make home repairs and Targeted Minor Home Repair assists home-owners who live in targeted areas.
