MODOT PROJECT UPDATES

MoDot will be utilizing a Zipper Merge as part of a bridge replacement project in Clay County. The project is taking place at Southbound I-35 over 69 Hwy in Liberty. The project started May 10th and will continue through the end of August.

NNI receives a lot of citizen complaints regarding left over election signs and promotional signs placed in yard and public right-ofway. What can be about these problems signs?

Chapter 88 of the Kansas City Municipal Code addresses what is allowable, not allowable, enforcement measures and fines. Enforcement of sign ordinance and regulations is carried out by the Development Management Division of the Planning Dept.

Yard signs are considered incidental signs and one sign per driveway is permitted in a residential dis-

Election signs are allowed during the period from 6 weeks prior to the election to 2 weeks after such election. No such sign may exceed 8 square feet or 4 feet in height. Signs are not permitted on trees, benches and utility poles.

In general, signs in the public right-of-way or on public property are also prohibited, but are allowable under specific terms detailed in Chapter 88. Such signs may not state commercial messages.

Council representatives from Districts 1, 2 & 4 have been invited to attend and Any other sign placed or installed in the right-of-way will be deemed an unlawful sign and an abandoned sign and will be subject to immediate removal by the City of Kansas City, without compensation to the owner. The owner or other person placing the sign will be subject to the penalty provisions of 88-615.

Violators are subject to a fine ranging from \$10 to \$500 for each and every day of the violations plus the cost of removal and disposal. However, the City will normally just remove the signs and send the owner a letter. Please report violations to 311.
