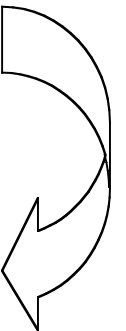

## "No Soliciting" stickers now available at NNI

To create a safer community in the northland, the North Patrol Division of the KCMO Police Department and NNI have developed a sticker to be placed at or near the front door of any Kansas City, Missouri residence.

Properly posted, stickers will warn solicitors they would be violating Kansas City, Missouri City ordinance 50-151 if they solicit business at that location. If a violation of the ordinance occurs, the resident has the option to contact the police department to respond and sign a complaint against the violator.

The sticker must be placed near the front door where it is clearly visible. If the violation warrants police involvement, residents should contact the non-emergency number for the KCMO Police Department at 234-5111.
