Good news on Antioch Mall

Sears pledges cooperation in rebuilding the iconic shopping center.

A top Sears official came to Kansas City August 24 to work out issues that had earlier led the giant retail firm to file a restraining order halting the planned start of demolition on Antioch Mall. The talks went so well that the filing was withdrawn. Friendly settlement of the dispute sets the stage for action by Antioch Redevelopment Partners (ARP) on the demolition. The permit application process began on August 25. ARP will provide NNI a general timeline for the demolition. NNI will share the timeline with Northland residents and businesses as soon as it is available.

Home repair blitz underway

eligible homeowners urged to apply now

NNI has received a series of government and foundation grants that will speed up home repair production. To be eligible, you must be a homeowner residing in Kansas City or Clay County, Missouri and household income must be below 80% of median income. (For example, a family of 2 with a total household income of \$46,300 qualifies.) Kinds of repair include heating and cooling repair and replacement, siding, windows, electrical, flatwork (concrete), flooring repair, plumbing, exterior painting, bathroom repairs, barrier removal, handicap accessibility or any other type of repair or replacement service that is not considered essentially cosmetic. The home repair grants can help seniors on fixed incomes stay in their homes, clear up code violations, and improve energy

efficiency resulting in lower household utility bills.

As part of NNI's "Aging in Place" initiative, seniors will be given preference on home repair applications. This initiative is based on evidence that seniors remain healthier, physically and mentally, when they can stay in their own homes and neighborhoods. Neighborhoods also benefit from the stability, experience and knowledge of their senior residents.

If you need home repair, you should contact NNI today at 454-2000 for a home repair application. NNI will assist in determining your income eligibility, plan the repair work and assign qualified contractors to make the repairs.

Larry Washington

closes Air Force career

Like many young men of draft age in 1972, Larry Washington wasn't overly excited about joining the army. He would have preferred to pursue his passion for race cars (which he still indulges) and get on with his life. He wasn't yet interested in college and could not afford an extended vacation in Canada. So, Larry found himself in Vietnam serving with a U.S. Army field artillery unit.

In the August 2011 issue of the 442nd Fighter Wing magazine, Larry talks about his time in Vietnam. "I had really good friends that I lost over there. It got to where I didn't want to get close to anybody. I feel like it's a dishonor to their memory for me to talk about it as if I'm a hero... because I'm not. It's something I'd like to forget," Larry says.

After Vietnam, Larry was away from the military for 8 years, then got laid off from a steel company in Kansas City. He began to think about college. That's when a friend who served in the Air Force urged Larry to talk to an Air Force

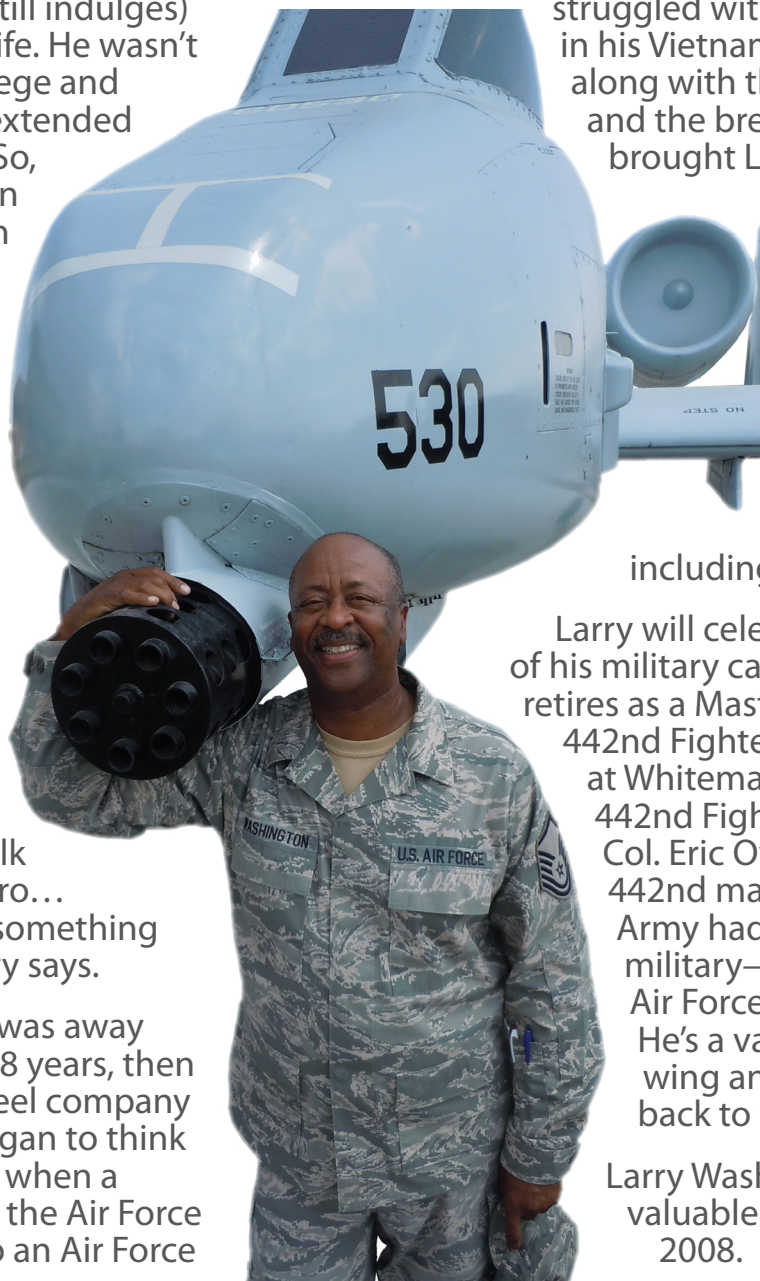
recruiter. He did and, in 1983, became a photojournalist for the 442nd Fighter Wing at Richards Gebaur Air Force Base. While serving in the Reserve and attending college, he struggled with alcoholism acquired in his Vietnam days. That problem, along with the death of his sister and the breakup of his marriage, brought Larry to some life-

changing decisions. He quit drinking and smoking and "the blessings just started pouring in," Larry says. His religion became a central force in his life and it "changed everything,"

including his Air Force career.

Larry will celebrate the closing of his military career this month. He retires as a Master Sergeant with the 442nd Fighter Wing reserve unit at Whiteman Air Force Base. As 442nd Fighter Wing commander Col. Eric Overturf says in the 442nd magazine article, "the Army had to drag him into the military—and 39 years later, the Air Force had to drag him out. He's a valuable asset to this wing and one we hope comes back to visit—often."

Larry Washington has been a valuable asset to NNI since 2008.
