NNI newsletter moves to weekly format in January 2012

Neighborhood organizations are in the information business. They need information about city services, updates on the redevelopment of Antioch and Metro North shopping centers, progress reports on projects like Chouteau Parkway, and many other issues. One of NNI's most important roles is

to provide information to neighborhood associations so they can spread the word to their residents. "Northland Neighborhoods uses e-mail, public meetings, and our newsletter to keep our neighborhoods informed. And we're always looking for ways to do our job better. That's why we are going to a weekly newsletter," says NNI CEO Deb Hermann.

Starting Monday, January 2, and every Monday thereafter, NNI will e-mail a one-page (2 pages if necessary) newsletter with all the week's news, meeting schedules and special announcements. Persons who do not have access to a computer may request a printed copy. NNI will hone its journalism skills to be sure that every article is crisp, immediate and easy to read. As in the past, NNI is interested in getting articles from neighborhood newsletter editors when they have stories that would be of interest to other neighborhoods. Editors need to get the articles to NNI by Wednesday prior to the Monday publication date.

Antioch Crossing gets TIF Commission blessing

work begins


Redevelopment of Antioch Mall is on its way. The project won approval of the Tax Increment Financing Commission on the morning of November 9 and, by late afternoon, construction fencing was in place and utility relocations began. Environmental cleanup has also begun and will be completed by December 9. In the meantime, ARP, the owners/developers of Antioch Crossing, are preparing to go before the City Plan Commission and on to the City Council, the final

step in the approval process.

When the utility work is completed, Phase I site work, which includes demolition of the Mall south of the Burlington Coat Factory, should begin immediately. Exterior demolition will not be visible from the street until after January 1, 2012. Projections for completion of the demolition and abatement of this section of the old shopping center are still set for spring 2012.

Home repair grants available for eligible homeowners

If you are a Northland homeowner and need a new roof, windows, heating and cooling systems, siding, a driveway or other repairs, NNI has grants that can get these needed repairs done. Household income must be below 80% of median income. (For example, a family of 2 with a total household income of \$46,300 qualifies.) The home repair grants can also help seniors on fixed incomes stay in their homes, remove barriers to accessibility, and improve energy efficiency, resulting in lower household utility bills. Contact NNI today at 454-2000 for a home repair application. NNI will help determine your income eligibility, plan the repair work and assign qualified contractors to make the repairs.



Chouteau Parkway project moving at a crisp pace

Most of the recent work on the parkway project is underground, but don't be deceived. Things are happening. While utility crews are busy with relocating cables, environmental hazards are being removed from the structures that remain standing. By mid-January, the remaining demolition will be completed and bids will be opened for the actual parkway construction. Barring a prolonged winter, construction should begin by spring 2012.


