# Deb's Desk (a weekly update from CEO Deb Hermann)

#### NNI participates in meeting with HUD Secretary

Secretary of Housing and Urban Development Shaun Donovan met with area community development organizations April 23 at the Mid America Regional Council in downtown Kansas City. Thanks to an invitation from Congressman Emanuel Cleaver (whose district will soon include a significant portion of the Northland), I was privileged to represent NNI at the meeting.

The Secretary opened the discussion by reporting that billions of dollars in penalties banks paid by the nation's banks for poor foreclosure practices had been distributed to the states. Missouri received \$40 million. The expectation was that the states would use their windfalls to begin correcting the foreclosure epidemic. But Missouri chose to use all but \$2 million of its windfall to restore education funding, which had been hit by budget cuts. Mr. Donovan also expressed concern over the future of block grant funding (which pays for much of NNI's home repair and purchase-rehab programs).

While we all wanted to hear what the Secretary had to say, Mr. Donovan clearly preferred to listen to us. And he did. He is in sync with NNI's commitment to sustainable community development. (In NNI-speak, that means a
