#### MODOT PROJECT UPDATES

Northbound and southbound I-435 over Route 152 will be reduced to one lane in each direction from May 31st to June 22nd for bridge rehabilitation work. The ramps from Route 152 to I-435 will also be closed.

NNI is committed to assisting neighborhood efforts to preserve neighborhood property values and prevent crime. NNI works in partnership with stakeholders to keep Northland homes, vacant lots and business properties well maintained.

The goal is prevention and abatement of property codes and nuisance codes violations. NNI works closely with area partners to provide education, minor home repair services.

The preferred method of abatement is to work directly with property owners to address the problem, bringing in resources as

needed. If NNI becomes aware of a potential codes issue it all starts with an on-site inspection.

NNI's Neighborhood Preservation Committee is a forum for submitting and discussing potential cases. NNI staff and KCMO Codes Enforcement officers attend meetings and work with citizens on a course of action.

Sometimes all it takes to get the problem addressed is a visit and letter from NNI. Should a letter not result in corrective action NNI will move on to more visible measures by utilizing Codes Enforcement and Legal Aide of Western

Missouri resources.

NNI can and will invoke specific Missouri State Statutes to acquire property from those owners that fail to timely respond to complaints and correct the issues creating a problem.

NNI has initiated steps to acquire several properties. However this is the last resort course of action.
