please Bother Us

It is frustrating for police officers when a citizen describes criminal activity to them long after it occurred and then discover that the citizen did not call 911. Many times the resident will explain that they didn't call 911 because they didn't want to "bother" the police. They will remark that they are sure that other citizens are having more serious issues.

Certainly, none of us want the police being called needlessly. However, there are times when the police should be called to protect citizens and their rights.

Observance of Crimes or Suspicious **Activities**

One of the primary reasons why criminals get caught is because they were seen by neighbors or other witnesses. If a person personally witnesses a crime, he or she should immediately call the police as long as it is safe to do so.

Even if a person is not certain that a crime has been committed, it is important that citizens report suspicious activity to local law enforcement. This may include hearing screaming or shouting nearby, seeing an unknown person enter a neighbor's home when the neighbor is not usually home at that time, seeing people that neighbors do not recognize in the neighborhood that appear to be casing the area, such as looking

in windows and cars, hearing loud noises, hearing dogs barking or hearing broken glass. Vehicles may also seem suspicious if they are driving slowly through the area, driving without lights or driving without license plates.

Safety Is Threatened

If a citizen's life or that of another is threatened in any way, this information should be immediately reported. A call may help protect someone from foreseeable injury or even death. Any threat that a person takes seriously should be reported, whether it is through an in-person communication, in-person conduct, threatening phone call or other communication. The threatening communication should be provided to law enforcement, if possible.

Special care should be taken to notify law enforcement if vulnerable individuals are being abused or mistreated, such as children or the elderly.

To Document Events

Sometimes it is necessary to contact the police in order to document certain events. For example, if jewelry is stolen out of a home, the owner would want to contact the police to document the theft in order to report it to the insurance company. A domestic violence victim may wish to contact the police in order to report the abuse, as well as to gather evi-

dence necessary to help obtain a restraining order, such as by having the police take pictures of the injuries and interviewing witnesses. Neighbors or other individuals who are harassed may also choose to contact the police to document these communications.

Individuals who report criminal or suspicious activity should provide as much detail as possible, including the time that the event was witnessed, the location of the event, a detailed description of the suspect, and information about the vehicle including make, model, color and license plate number. Any other helpful information should be provided, such as the direction in which a suspect was fleeing. The above information can help the dispatcher ascertain the nature of the complaint and the services immediately required.
