Kansas City Climate Plan Update

Andy Savastino, Chief Environmental Officer KCMO, visited with NNI's monthly neighborhood roundtable, chaired by Board Member Henry Clark, to discuss recent updates made to the city's 2008 Climate Protection and Resiliency Plan.

Savastino presented the changing climate's impact on Kansas City and provided details on how the city will aggressively achieve its lofty goals. The City Council approved new goals for the city to become climate neutral by 2030 and city operations by 2040.

"In this particular effort, we're moving beyond just mitigation strategies and moving into adaptation strategies as well " said Savastino, a 28year city veteran.

Climate experts predict the Kansas City, MO could feel more like Houston, TX in twenty to thirty years. Rolling brownouts and blackouts could gradually get worse, and our landfills may be full in 10 years.



When it's full, the city will export trash to regional landfills costing taxpayers more money.

"Recycling is not that hard. We need to work hard to save Mother Earth," said Mary Clark, Cooley Highlands. "How hard is it to place recyclable items in a bin?"

Savastino led a nearly two year study, creating a city-wide plan that moves Kansas City away from mitigation strategies and towards resilient, equitable, and adaptive measures for the ever-changing Midwestern climate.

Citywide carbon neutrality calls for extraordinary measures, such as the proposed 3,000 acre solar-panel farm next to the new Kansas City International Airport. Preliminary studies are underway to see if the terrain is suitable and can connect to the city's power grid. A solar farm of this capacity would generate more than enough energy to supply Kansas City.

Just. No.

On April 7th Jeff Fulton asked the NNI Planning and Development Committee to support his desire to redevelop the US Bank site at N. Brighton and NE Vivion Road. into a used car lot.

Committee members collectively voiced the following concerns:

- The proposed project is clearly not in compliance with policies adopted by the city council, through the Briarcliff/Winnwood Area Plan and Vivion Road Streetscape Plan.
- The proposed project would have a negative impact on the adjacent residential neighborhood, especially those homes bordering the project boundary.
- There is no community need for an additional used car lot.
- The proposed project would not provide any improvement to the corridor but would reduce the value of surrounding properties and have a deleterious effect on future private investment in the corridor.

Dave King said, "We want you to build your car lot; just not here."

NNI will monitor the progress of this application and continue work to bring positive development to the corridor.

NNI Hosts First Listening Session

The Northland Regional Chamber of Commerce hosted the first of six 'Kansas City, Missouri Police Chief Community Listening Sessions' at Northland Neighborhoods, Inc. on March 29. The public forum allowed residents and community leaders to express what qualities they'd like to see in the next chief of police with regards to transparency, accountability, and community engagement.

"Too many times, we will hear people say they are not engaged because nobody is asking; well, we're asking them to be engaged." Said Ron Lindsay, Greater Kansas City Chamber of Commerce.

A coalition of community, civic, and business groups organized the listening session, which was well attended by the public and various media organizations. Governor Mike Parsons appointed the Board of Police Commissioners to conduct a nationwide search to replace current Chief of Police Rick Smith, who retired on April 22. Deputy Police Chief Joseph Maybin stepped in as interim Chief on the 23rd until the board finds a permanent replacement for Smith.

The findings from the discussion will be presented to the Board of Police Commissioners. Typically, the search committee decides on two final candidates *and then* seeks public input. The police department in partnership



with the different area chambers of commerce and community organizations, such as NNI, are engaging with the public *well before* candidates are chosen.

"They will hear what Kansas City wants in a police chief. This has never happened. It's never happened to this magnitude," said Pastor Darron Edwards from "Getting to the Heart of the Matter".

Some questions asked at listening session:

- Describe what community engagement from the new KCPD Chief of Police looks like to you?
- Describe what transparency from the new KCPD Chief of Police looks like to you?
- Describe what accountability from the new KCPD Chief of Police looks like to you?
